In Scope:

- Purchases that will require a competitive solicitation
- Purchases that will be obtained through the sole source process
- Non-competitive procurements for single purchase in excess of \$20,000 (this does not apply to sole source contracts)
- Non-competitive procurements with a statement of work in excess of \$30,000

Out of Scope:

- Statewide Contracts (including two-tier contracts)
- Emergency Purchases
- Interagency Agreements (IAA)
- Current Contracts unless being rebid
- Contract Amendments
